As we head into the fall season, I want to share some exciting updates about what's happening at Burleigh County Housing Authority and Community Homes of Bismarck, Inc.. This has been a year of growth, transition, and continued commitment to ensuring that families, seniors, and individuals in our community have safe, affordable housing opportunities.

Housing Updates

- Dakota II We're building 34 new homes, including a 20-unit apartment for seniors 62 and older and 14 family townhomes. Construction is underway, and we expect them to be ready in early 2026.
- Washington Court Renovations are almost finished at our 96-unit community! The work is expected to be wrapped up by the end of this year, giving residents updated and improved homes..

What is an NSPIRE Inspection

NSPIRE stands for the National Standards for the Physical Inspection of Real Estate.

It is a new physical inspection model developed by HUD aimed at reducing health and safety hazards in homes. NSPIRE focuses on accurately assessing the condition of dwelling units, implementing streamlined inspection processes, and prioritizing the health.

NSPIRE inspections are scheduled by HUD and units are selected randomly on the day of the inspection.

BCHA receives an overall score of the property after the inspection and must correct all deficiency. Each deficiency has a timeframe for when corrections needs to be completed.
